Dear Tennis Enthusiasts,

I am happy to inform you that the 2011-2012 indoor bubble season will open for play Saturday, October 1, 2011 through and including Sunday, April 29, 2012. The bubble season is 29 weeks.

We are happy to announce that this year's contract rates will be the same as the last six years. The Club and bubbles will be closed Christmas Day and New Year's Day. There will be no contract time on Thanksgiving Day (Nov 24), Christmas Eve (Dec 24), Christmas Day (Dec 25), New Year's Eve (Dec 31), and New Year's Day (Jan 1). (See the enclosed chart for exact contract dates as make-up sessions for these holidays are not necessary due to the extended schedule). Our court time prices are considerably less than at other comparable facilities. The club reserves the right to assign the courts as necessary.

Club members who sign and return a contract to the club office by July 20, 2011 will be entitled to a 10% discount provided that all applicable contract fees are paid by **August 31, 2011**. This discount is only being offered to WSTC members.

Additionally, to receive the 10% discount, club members must also sign and return the contract(s) to the club office by **July 20, 2011**. **After the July 20, 2011 deadline all unsold contract time will be available on a first-come first-served basis.**

All court captains are responsible for the payments of their non-member players.

Billing will be through club accounts. Checks or VISA/MasterCard will be accepted from non-members. All applicable contract fees must be paid by **August 31, 2011**. Time slots for contracts not fully paid for will be considered available for sale. All contracts are binding.
